

**The status of completion and progress of investments approved by
Myanmar Investment Commission in June and July 2019**

1. Myanmar Investment Commission (MIC) has provided approval for foreign and local investment in accordance with Myanmar Investment Law.
2. The total foreign investment amount including increased investment, reached US \$ (660.328) million in June 2019 and US\$ (366.474) million in July 2019 respectively.
3. The foreign investments permitted by MIC in June and July 2019 were as follows;
